the tribunal confirmed:

*A—Violation of the rights of man and of the rights of the peoples.*

# On the rights of man

Recalls that in its session in Rome it declared the de facto authorities who exercise power in \_\_\_\_\_, Chile \_\_\_\_\_ to be guilty of serious, repeated, and systematic violations of the rights of man, and confirms this sentence;

Furthermore, taking into account the magnitude of the aforementioned violations, it declares that taken together they constitute a crime against humanity, committed in each of these four countries by the same de facto authorities

# On the rights of peoples

Declares the activities of multinational corporations to be threats to the sovereignty and the rights of the people;

Declares that the activities of multinational corporations and of other foreign investors in Latin America justify their nationalization, either without compensation, in the form of sanctions, or by reducing their excessive profits;

Declares as well that the payments made to the multinational corporations by the illegitimate and repressive governments are in violation of the nationalization laws and the rights of the people, lack all validity and eliminate all statutes of limitations for those who have received these payments and those who have carried them out.

Denounces the attempts made by the multinational corporations to be recognized as plaintiffs by international law, declares that they should be exclusively subject to national jurisdictions and that the establishment of special jurisdictions and agreements between the States and the multinational corporations is in violation of international law;

Declares that some among them have become coauthors of the fascist coups, as in the case of I.T.T. in Chile;
